# THE ORGANIZATION SETTING

The African Civil Aviation Commission (AFCAC) is a specialized agency of the African Union responsible for Civil Aviation matters in Africa. Its objectives are to coordinate civil aviation matters in Africa and to cooperate with the International Civil Aviation Organization (ICAO) and other bodies, which are involved, in the promotion and development of civil aviation; and, as an Executing Agency of the Yamoussoukro Decision (YD), AFCAC facilitates, coordinates and ensures the successful implementation of the Single African Air Transport Market (SAATM).

The mission of AFCAC is to facilitate cooperation and coordination among African States towards the development of an integrated and sustainable air transport system and foster the implementation of ICAO Standard and Recommended Practices (SARPPs); and the Commission's vision is to have a liberalized, safe, secure, environment friendly, reliable, sustainable and modern air transport industry in Africa.

AFCAC's main responsibility as the Executing Agency (EA) is to ensure the consistent and full implementation of the Yamoussoukro Decision (YD) and the realization of the Single African Air Transport Market (SAATM) towards contributing to the African Union Agenda 2063. The objective is, amongst others, to facilitate seamless and smooth operationalization of the SAATM to ensure the sustainable development of air transport and those activities of the Executing Agency (EA) facilitate the growth of the intra-African Air Transport Market.

The EA's role, therefore, ensures the even-handed enforcement of the YD and the EA's regulatory oversight responsibilities across all AU member States and their s consistent application of and adherence with the Regulatory and Institutional Legal Instruments of the YD, its Operational Rules and Procedures. It also ensures that the operationalization of the SAATM creates a conducive environment for sustainable development of air transport in Africa.

The Director of Aviation Safety and Infrastructure reports to the Secretary General.

#### SUMMARY OF FUNCTIONS AND RESPONSIBILITIES-IMPACT OF OUTCOME OF THE POSITION

The Director of Aviation Safety and Infrastructure has the overall managerial responsibilities of the Directorate of Aviation Safety and Infrastructure by supervising and coordinating the work of the staff members of the Directorate. He/she promotes the implementation of AFCAC policies in Aviation Safety, Aerodromes and Air Navigation Services. He/she directs the execution of AFCAC aviation safety and infrastructure development programmes for the benefit of the Members States. He/she also ensures the development of regulatory mechanisms in the field of Aviation Safety, Security and Infrastructure.

#### **MAJOR DUTIES AND RESPONSIBILITIES**

- Responsible for the direction and coordination of the Directorate of Aviation Safety, Security and Infrastructure and monitor/follow-up on the relevant policies, reports and documents in these fields:
- Participates and contributes to the development of a regulatory mechanism in the field of aviation safety, security and infrastructure;
- Promotes and fosters the development of a common aviation safety, security and infrastructure policy in Africa;
- Promotes and fosters the harmonization of the rules and regulations in the field of aviation safety, security and infrastructure;
- · Promotes both efficiency and efficacy of the African civil aviation industry;
- Fosters the exchange of information relating to civil aviation safety and infrastructure among African States;
- Contributes to the enhancement of a strong culture among all Member States in the field of civil aviation for safety, security and Infrastructure;
- Contributes to the establishment of measures regarding aviation safety operations and programmes related to infrastructure and work in close collaboration with Air Navigation Service Providers and Airport Authorities;
- Participates in the establishment and development of a training programme in the field of Aviation Safety, security and Infrastructure for the stakeholders of the civil aviation sector in Africa;
- Fosters the implementation of ICAO Standards and Recommended Practices (SARPs) for the safety, security and regularity of the civil aviation sector;
- Contributes to the development and implementation of measures aiming at the protection of the environment;
- Provides necessary support to the Secretary General and contributes with solutions to the issues facing the African civil aviation in the field of both Aviation Safety and Security;
- Represents AFCAC in international meetings on aviation safety, security and infrastructure;
- Participates in and/or supervise, as necessary, the working groups, committees and subcommittees pertaining to aviation Safety, Security and Infrastructure;
- Drafts Working Papers for the Plenary Session, the Bureau and for any other meeting to which AFCAC's participation as required;
- Assists Member States to prepare for ICAO audits and address both their Safety and Security deficiencies;
- Assists in the development and implementation of aviation safety and security targets as well as
  facilitating the maintenance of data on the status of achievement by Member States;
- Coordinates technical cooperation and assistance programs to achieve an enhanced level of aviation safety and security through collaboration with all key Stakeholders which include the AFI-CIS, AFI-CES, airports & air navigation service providers;
- Drives initiatives to strengthen RSOOs and capacity building through the sharing of information and best practices;

- Assists in the establishment of a Common Platform among RSOOs, CAAs, ANSPs, Airports and ATOs to share experiences and best practices in order to enhance efficiency;
- Facilitates the establishment of systems to enable seamless ATM services in accordance with the Abuja Safety Targets;
- Manages and coordinates the work of the Security Programme of AFCAC as well as facilitating transfer of knowledge and best practices including the SARPs to Member States counties.
